Patents	Term restoration
Biologics	5 + 3 years of protection
Trade Secrets	Criminal provisions
Trademarks	Nice Agreement + expansion
Geographic Indications	Confusion

Privacy

Issue	TPP
Enforceable Privacy Laws	Enforcement of "Voluntary Undertakings"
Data Localization	Prohibited with uncertain exception
Data Transfers	Prohibited with uncertain exception
Tough Anti-Spam Laws	Weaker "opt-out" sufficient

Digital Policy

Issue	TPP
Net Neutrality Rules	Limited rules focused on blocking of content
No prohibition on mandated source code disclosure	No mandated source code disclosures
Independent ccTLD policy	Required conditions for country code domains
Mobile roaming costs	No enforceable provisions

Mandated support for culture	Ban on new support mechanisms
Governments considering Internet gaming regulation	Restrictions on new regulation
Governments considering ride sharing regulation (ie. Uber)	Restrictions on new regulation
