## Advancing a Diversified, Green Economy

While sustainable development has long been a goal for all countries, significant gaps remain. For Canada, where natural resources are key, the challenge remains to define what a green economy entails. Financing this transition is a prerequisite. In Canada alone, billions of dollars in low-carbon and climate-resilient investments are needed, but there is little idea of how to mobilize this capital and how government can enable the investment required for a green economy. ## Freshwater Management

IISD has wide knowledge and research capacity in freshwater management in Canada and abroad. This reputation was enhanced by the 2014 agreement that saw IISD take over responsibility for the Experimental Lakes Area (ELA) in northwestern Ontario. Unique in the world, this research facility (now IISD-ELA) allows for whole-ecosystem experiments in lakes and watersheds.

- ELA's ground-breaking research into acid rain, mercury pollution and aquaculture is being augmented by new studies into the impact on water systems of climate change and new contaminants including pesticides and flame retardants.
- Our award-winning Lake Winnipeg Bioeconomy program is developing opportunities for farmers to generate low-cost bioenergy and contribute to carbon offsets while fighting phosphorus pollution.

## Developing Indicators to Measure Progress

The path to sustainability requires information that tells us where we are, where we are going and how best to get there. This means developing tools to set goals while implementing systems that track progress critical to achieving a resilient and sustainable future.
